Purpose: "Payments for Merchants":
A non-profit trade association for cost-effective interest representation and general information exchange on issues relevant to payment providers for merchants in Europe.

Membership: Members shall have an essential business interest in providing commercially successful payment services to merchants in Europe (but: "no issuers, merchants, or consultants").

To have the status as a voting member, more than 50% of the sales revenues must be directly with payment and supporting services for merchants in the EU or EFTA.

To become a member, an endorsement by two EPSM members is necessary.

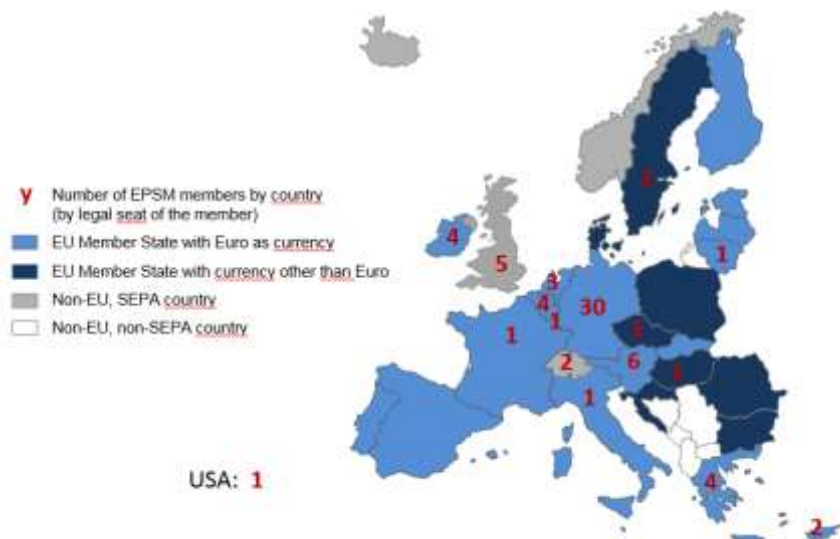
Costs: Annual Membership Fees: 1.400 Euro per calendar year
